ORDINANCE NO. 2023-

**AN ORDINANCE REPEALING AND RECREATING SECTION 7-1-6(b)(2),
RELATING TO DEEMING A DOG VICIOUS
OF THE MUNICIPAL CODE OF THE CITY OF HORICON**

THE COMMON COUNCIL OF THE CITY OF HORICON DOES ORDAIN AS FOLLOWS:

Section 7-1-6(b)(2) relating to deeming a dog vicious of the Municipal Code of the City of Horicon is hereby repealed and recreated to read as follows:

7-1-6(b)(2) A dog will be deemed as being vicious if it bites two (2) or more persons, domesticated animals, or a combination of both, within any twelve (12) month period, of if the dog inflicts an injury for which one (1) person or domesticated animal requires or receives medical attention. Instances are counted upon conviction of legal cases.

This ordinance shall become effective upon passage and publication as provided by law.
